INTRODUCTION:


Medical Tourism is an old concept dating back to ancient Greece, when Greek pilgrims travelled from all over the Mediterranean to the small territory in the Saronic Gulf called Epiduoria. Eiduoria became the original travel destination for medical tourism. Medical Tourism can be defined as the process of travelling outside the country of residence for the purpose of receiving medical care. Medical Tourism is broadly defined as cost effective private medical care in collaboration with the tourism industry for overseas patients needing specialised treatment. Originally, the term referred to the travel of patients from less developed countries to developed nations in pursuit of the treatment not

available in their homeland. According to World Health Organization (WHO), Medical Tourism is defined as tourism associated with travel to health Spas or resort destinations, where the primary purpose is to improve traveller's physical well-being through a process comprising physical exercises and therapy, dietary control, and medical services relevant to health maintenance. As a result of globalization, increased number of people is travelling to other countries to get quality treatment at affordable prices. Health care attention i.e. both surgical and non-surgical procedures are another important factor for Medical Tourism. In developed countries, the cost of treatment is very high, further the patients have to wait for a very long time to get treatment or surgery. This has prompted people to look at other effective options. Among these options is looking for treatment in other countries having good treatment facilities at a very reasonable cost. Growth in the popularity of Medical Tourism has captured the attention of policy makers, researchers and the media. Today we are experiencing both qualitative and quantitative shifts in patient mobility, as people travel from richer to less developed countries in order to access health services. The primary reason that clinics and hospitals in the developing countries are able to lower their prices is directly related to the nation's economic status. We can see that the cost of surgeries in these countries is 30% to 70% lower when compared to U.S.

Recently in October 2017, the third edition of "Advantage Healthcare India" 2017 summit was held in Bengaluru (Karnataka) by FICCI. In this summit, Rita Teaotia secretary, ministry of commerce Govt. of India said that Medical Tourism in india can grow to become a \$9 billion by 2020 as compared to \$3 billion in 2015. According to latest FICCI report, over 500,000 foreign patients seek treatment in India every year. Similarly in December 2017, minister for Tourism Govt. of India M.R K.J. Alphons states in Lok Sabha that India is among the top six medical value travel destination of the world which also include Thailand, Singapore, Malaysia, Taiwan and Mexico, because of low priced health care procedures. The highend healthcare system in India is as good as the best in the world. India maintains not only a robust accreditation system but also a large number of accredited facilities (about 275 such facilities that match any global infrastructure). India has a good number (22) of JCI (Joint Commission International) accredited hospitals and compares well with other countries in Asia. These set of approved hospitals in India can provide care at par or above global standards.

Cutting edge technology to support medical diagnostics and medical procedures are employed by specialists in medical facilities. All recognized hospitals have invested a lot in supportive technology and operative techniques. Complicated heart surgeries, cancer care and surgeries, neuro and even general surgeries require high-end technology to continually better outcomes, minimize complications, enable faster recovery and reduce length of hospital stay. The recent advancements in robotic surgeries, radiation surgery or radio therapies with cyber knife stereotactic options, IMRT / IGRT, transplant support systems, advanced neuro and spinal options are all available in India. India's medical management and acclaimed specialists are quite comfortable in challenging themselves to new frontiers to provide solutions, always building on their expertise.

India has not only hospitals with world-class facilities but skilled world-class doctors and medical personnel too. Medical visa in India is issued to those foreign nationals who want to visit India solely for treatment of serious ailments in recognized hospitals/medical centers. Neuro surgery, ophthalmic disorders, congenital disorders, organ transplantation, renal disorders, cardiac problems, plastic surgery, radio-therapy, joint replacement etc. would come under serious ailments. However, the list is not exhaustive. The patients need to produce a medical certificate from recognized hospitals or medical centre in India, indicating the dates, place and duration of treatment. The initial period of visa will be up to one year

or the duration of treatment, whichever is earlier. The visa will be valid for up to three visits during one year.

Medical attendant visa is for attendant or family members of the patient coming for treatment. Maximum two attendants are permitted. The duration of visa is co-terminus with the visa of the patient. A certificate from recognized hospitals/medicals in India to the effect that assistance of one/two attendants is needed should be produced. The names of the attendants should be mentioned in the letter. The environment for most of the complicated surgeries is suitable in India. In India we have Appolo group of hospitals and research centres, Fortis hospitals, Tata memorial hospital and escorts group of hospitals and research centres, who cater these patients. A complete transplant or bypass procedures can be achieved for a tiny fraction of the cost for the same procedure in U.S. This lower cost includes significantly longer post-operative care in the hospital itself.

The American Medical Association has made a cost comparison study of healthcare in different countries. According to the statistics released by AMA, a knee replacement surgery would cost \$40,000 in US, \$10,000 in Thailand and \$13,000 in Singapore, while the same surgery would cost the person \$8500 in India. That gives India a certain edge when it comes to reasonable medical treatments. In addition, Indian doctors are renowned all over the world for their prowess and skills.

A heart valve replacement surgery would cost the patients \$200,000 in the US and \$90,000 in Britain while it would cost \$12,500 in Singapore and \$10,000 in Thailand. The same procedure in India would cost only \$8,000. While a bone marrow transplant would cost \$30,000 in India, in US it would cost anywhere between \$250,000-\$400,000 while in UK the cost would be of the order of \$150,000. Doctors in Thailand would charge \$3,500 for cosmetic surgery while those in US and UK would charge \$20,000 and \$10,000, respectively.



While one in three foreign patients in Indian hospitals were from Bangladesh, at 165,000 - only 58,300 of these were true medical tourists on a medical visa.



The highest average earnings per patient for foreigners in India are from Pakistan at \$2,906. Pakistan is followed by Bangladesh (\$2,084), CIS (Commonwealth of Independent States) countries (\$1,950), Russia (\$1,618) and Iraq (\$1,530), according to a first of its kind survey on export of health services by Directorate General of Commercial Intelligence and Statistics, part of the commerce ministry.
